

We have identified you as a potentially eligible candidate for emergency funding under the CARES Act. Directions are at the bottom of this page.

This will begin a short process by which we will confirm your eligibility and get you the funds you are eligible to receive.

This is the question. "Due to the Coronavirus disruption to classes at OSUIT, did you have additional expenses related to such things as food, housing, course materials, technology, health care, or child-care?"

We are only asking for a yes or no response. We are not requiring a list of expenses.

Some examples of qualifying expenses include:

- buying a computer for online classes,
- purchasing internet access for online classes,
- buying new texts or materials for classes;
- If you had to move because of the changes and had expenses related to moving;
- If you had health care expenses because of Coronavirus or because you could no longer access the campus doctor, those would qualify;
- If you had to make child care changes because of the change to classes or the close of campus, those expenses would qualify you to receive funds.

There are many other expenses similar to these that would qualify you for funding.

If you suffered a job loss due to the Coronavirus, this would NOT qualify as an expense, but as a loss of income. We recommend you contact our office for additional assistance through the regular financial aid process.

Answering yes does not guarantee you will receive funds.

Please don't delay. Once the budget is spent, there will be no more

awarding.
